RULES.

MR. C. NEWMAN.

1.—The Club shall be called "The Great Marlow Amateur Rowing Club," and shall consist of a President, Vice-Presidents, a Captain, a Deputy-Captain, an Hon. Treasurer, an Hon. Secretary, a Committee of Seven Members, and Honorary and Rowing Members.

2.-The Officers of the Club shall be ex-officio Members of the Committee.

3.—The Captain, in whose hands the selection of the Crews for Regattas, Races, etc., shall be vested, shall be elected annually with the other Officers, at the commencement of each season, by a General Meeting of the Club, which shall be held early in the month of March.

4.—The Committee shall be empowered to collect Subscriptions, draw up Rules, and make such other arrangements as may seem desirable.

5.—All Donors of Ten Guineas and upwards shall be Life Members, and all Life Members and Annual Subscribers of Two Guineas and upwards shall be Vice-Presidents of the Club,

6.-No Subscription shall be less than Half-a-Guinea.

7.-The Colours of the Club shall be White and Scarlet.

8. -Members subscribing One Guinea and upwards may introduce a friend to the privileges of the Club free for one week, and for one month upon payment of 5s., such friend not being resident in or within five miles of Marlow, and Members not having paid their Subscriptions within two months from the beginning of the season, or date of admission, shall be liable to be struck off the list of members.

9.—The Officers of the Club, with the exception of the Vice-Presidents, shall retire annually, but shall be eligible for re-election.

10.—The Committee may at all times call a General Meeting, and shall do so at all times within seven days after receiving a requisition to that effect, signed by not less than eight members.

11.—Members shall be admitted by Ballot, at a Committee Meeting, upon notice being given to the Honorary Secretary. Two black balls in five to exclude.

12.--The Committee shall meet at 8 p.m., on the first Thursday in every month, five to form a quorum.

13.-The season shall commence March 25th, and conclude September 29th.

14.—Members wishing to resign shall tender their resignation in writing to the Honorary Secretary, on or before February 1st, otherwise they will be liable for the year's subscription; the receipt of such resignation to be acknowledged by the Honorary Secretary.

BYE-LAWS.

1.- It shall be compulsory for Members rowing in Regattas or Matches to wear the Club colours.

2.—The Entrance-money for Regattas, Carriage of Boats, etc., and such individual expenses as the Committee may award, shall be paid out of the general fund.

3.—Members may at all times use the Club boats for practice, Sunday excepted; but after six o'clock p.m., no crew may keep a boat for more than one hour, if required by another crew, without the permit of the Captain, or in his absence the Deputy Captain, and in the event of any infringement of this bye-law, the Captain is empowered to inflict a fine on the crew of not more than 10s. for every hour or part of an hour.

4.—No person shall be allowed the use of the Club *materiel*, except he be in the company of one or more members.

5.—Damage wilfully or by gross negligence occasioned to the property of the Club, shall be immediately repaired at the personal expense of the offender; but accidental damage shall be borne by the Club. The question of damage being accidental or not shall be decided by the Committee.

6.—No crew shall row for a public prize in the name of the Club without the sanction of the Captain.

7.—All boats shall be returned to the Club House by Ten o'clock p.m., except by authority of the * Captain, or in his absence, of the Deputy Captain.

8.—The Committee shall have power to enquire into the conduct of any member which may appear to be discreditable, and if necessary, to punish any such offence with expulsion from the Club.

THE MONTHLY CHALLENGE CUP

Will be competed for on the last Tuesday in every month.

Entries may be made to the Hon. Sec. up to within fourteen days of date of competition.

The Captain will nominate Stroke, and three of each crew from the list of entries, numbers one and two will be decided by ballot.
